### PROJECT APPLICATION FOR CENIIT 2020

Applications for project funding for 2020 (both current and new projects) shall be submitted **no later than 2019-09-13**. Applications after this date will not be considered for funding. Applications shall be submitted in electronic form (PDF file) by email to CENIIT manager Erik Frisk <erik.frisk@liu.se>. The submitted application is considered an internal document and is not public.

The applications will be discussed at a meeting on 2019-10-04 and the recommendation by the CENIIT board to the LiTH board will be made available to the applicants at the earliest time after decision. A description of the board's policy for CENIIT can be found at http://ceniit.lith.liu.se/ where also descriptions of current projects and the members of the board can be found.

## **Applications for new projects (including projects with planning funding)**

The description below applies to applications for new projects and projects that during the previous year have had planning funding. Planning funding typically corresponds to 1/2 of a regular CENIIT grant. For projects with planning funding, it is important to relate to any instructions from the board given at the last application review.

#### In general:

- Applicants are strongly encouraged to contact a board member before the decision meeting to discuss the project. This board member can then act as project rapporteur. If you need help selecting who to contact, contact Erik Frisk <erik.frisk@liu.se> for guidance.
- A template for the application document can be downloaded from the CENIIT website.
- Projects with planning funding shall apply using the template for new projects.
- All applications for new projects are asked to preliminary book 11.00-15.00 on 2019-10-04 for an interview with the board.
- Qualified to apply is a person with a doctoral degree, active within LiTH, who is not a professor.
- A person/project can normally be funded for at most 6 years.
- Preliminary, a full CENIIT grant is 450 000 SEK/year.

An application for a new CENIIT project shall contain the following parts and be approximately 5 pages (excluding CV):

• A description of the project background.

- The projects position with respect to the international research frontier and industrial relevance.
- A description of the research environment in which the project is performed.
- A description of the project vision on a three-year perspective and also long term with respect to research activities, independence, and plans to form an independent research group.
- A description of the proposed project's connection to industry by describing the connections to one or several partner companies, including contact persons. It is strongly encouraged that one, or several, letters of intent from concerned companies are included in the application. A description of how the collaboration with partner company/companies will take place is also recommended.
- A detailed plan, including objectives and activities, for the first year.
- A budget for the project. From the budget it shall be clear which researchers/PhD-students that is partly financed by the project. A limited part of the funding can be used to visit collaborating companies with the purpose of developing the project and disseminate project results.
- An overview of other grants that are intended to support the project.
- CV for the intended project leader.

## Applications for continued funding of existing projects with full funding

Applications shall include a project report of about 2-3 pages with the following content:

- A description of the project background and industrial motives.
- A description of the long-term objectives of the project.
- A description of current project status and the results that have been achieved.
- A description of collaboration with industry by naming industrial partner, contact person, and forms of collaboration.
- List of publications.

The project report can consist of the description that has been linked to the CENIIT website under the condition that the project description is updated. In addition to the project report, the application shall include:

- A detailed plan including objectives and activities for the upcoming years.
- A detailed economical account for how the grant has been used during previous year. It shall be clear which persons, and to what percentage, that has been funded by CENIIT. It shall also be reported how concerned persons are otherwise financed.
- A budget for the upcoming year.
